Mental Health Committee Case Study – M.C.

March 2, 2015

Initials M.C

- 34 year old Black male
- Name added to 2014 Heavy Utilizer because he was on Municipal Court's List (Seen by case management provider 5+ times in recent 3 year period)

Municipal Court Involvement

- 34 City of Milwaukee municipal citations from December 2009 to January 2013
- Owed a total of \$1,247 as of early January 2015. Currently owes \$0.
- Municipal infractions include: Aggressive Panhandling (5), Loitering in Restaurant, Tavern, Etc. (1), Loitering or Prowling (1), Possession of Drug Paraphernalia (4), Retail Theft (13), Trespassing Upon Buildings/Premises (10)

Circuit Court Involvement

- 24 misdemeanor cases between 2007 and 2014 (see attachment)
- 23 of his cases were principally for retail theft. The other case was for resisting or obstructing an officer. Some cases had additional charges for bail jumping.
- M.C. was usually given time served or probation.

Jail/HOC Involvement

- 37 Jail bookings between 1/31/2007 and 12/8/2014
- A total of 1,782 days in custody at the Jail/HOC from 1/31/2007 to 2/26/2015 (still jailed as of that date)
- There are 2,948 days from 1/31/2007 to 2/26/2015. This means that MC has been in the Jail/HOC for 60% of that time. This does not include any prison history.
