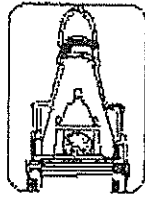

PRINCIPAL EXPENSE STATEMENT

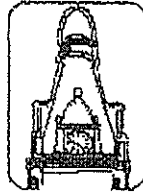
