DEFINITION:

The Milwaukee Code of Ordinances allows the issuance of a permit to distribute publications via a rental box at City Hall under specific circumstances. Upon application, a permit may be issued to a “person, group, organization or other association “to distribute “newspapers, newsletters, magazines or other publications which are published daily, weekly, biweekly, monthly or on other similar regular schedules.”

LICENSE PERIOD:

License expires 2 years from date of issuance. License must be issued within 1 year of approval, or a waiver from the Licenses Committee is needed.

FEE:

\$35 per box must be submitted with the application.

APPLICATION:

An application must be completed and signed by the applicant. No more than two spaces will be allotted for the same publication.

After completion of an application provided by the City Clerk’s Office and payment of the fee, the City Clerk will review the application and, if appropriate, issue the permit and designate a box in the City Hall rotunda for distribution of the publication.
