

Economic Stimulus Task Force



Dear Constituents:

After a successful second election to serve as your Supervisor on the Milwaukee County Board, I have focused on my pledges to advocate for the services and policies that you care about: preserving our **parks**, fighting for a healthy **transportation** system, and making responsible **fiscal** decisions that hold the line on taxes.

As a member of the Committee on Transportation, Public Works, and Transit, I have helped oversee smooth operations of the Airport, urging repairs to our County roads, particularly **College Avenue**, and directing attention to the impending **fiscal crisis in our transit system**, which could decimate our bus routes.

I led a coalition of elected officials to tell the State that we are not interested in proposals to demolish the **Dan Hoan Bridge**. Our residents depend on this bridge and believe that we, as a state, should invest in its maintenance.

Our Parks system continues its recovery from June 2008 storms that caused an estimated \$20.5 million in damage. I advocated for restoration of Mill Road and the Pedestrian Bridge in South Milwaukee, two treasured structures maintained by Milwaukee County. However, much work remains to preserve our many Parks that suffer from deferred maintenance. I am proud of our wide range of Parks offerings, including **cycling opportunities**, **summer concerts**, and **dog-friendly areas**. Our Parks need involved users and a dedicated source of funding to stay great!

As a member of the Committee on Finance and Audit, I considered the County Executive's Recommended 2009 Budget, keeping in mind the priorities that my constituents have articulated: maintain our **roads**, **bridges**, and **transit system**; effectively manage our **Airport**; preserve our **parks** and other assets; and keep property taxes under control. I continue to run my own office in a fiscally responsible manner as well to be a good steward of your tax dollars. My 2008 and 2009 travel budget was \$0.

Please continue to contact me with your budget concerns as we enter 2010 Budget deliberations this fall.

In addition, my role on the County Board's **Task Force on Economic Stimulus** has allowed me to provide input and identify opportunities for our district to receive needed funding. I authored the County's current policy to seek Economic Stimulus funding, which was approved on a 16-2 vote by the full Board.

I strive to keep 8th District residents informed of my work on the Board. I am one of the first Supervisors to create a monthly e-newsletter to keep constituents updated on issues affecting our district. Rawson Avenue (between Pennsylvania/Nicholson and Howell). Later this summer, the Parks Department will open another dog exercise area in Bay View Park on the northern end of St. Francis, overlooking Lake Michigan. FINANCE AND AUDIT

Pension Obligation Bonds

Milwaukee County has an under-funded pension and is required by federal rules to budget over a five-year period to correct the under-funded amount. Additionally, we are penalized 8% for the under-funded pension. We have been living on a credit card and Pension Obligation Bonds (POBs) are a way to consolidate our debts and become responsible by paying off these high penalties. I worked with County Executive Scott Walker in getting this done because I felt it was fiscally responsible.

We have listened to good expert advice. I explored the issue of doing nothing and the result is much worse. For this reason, I voted with 10 colleagues and the County Executive in favor of issuing POBs. It appears that we did this at the right time as we realized an interest rate of 6.3%, just before rates began to climb.

Mercer Lawsuit

Milwaukee County is involved in a lawsuit with Mercer, the advisor hired by Milwaukee County. We have alleged that Mercer was negligent in giving advice to the board regarding the backdrop and other pension benefits. This lawsuit was scheduled to go to trial during the publication of this newsletter. Please check my monthly e-newsletter for more information as the trial proceeds.

Economic Stimulus

As the new Presidential administration delivers an economic stimulus package, I have worked to ensure that our South Shore communities receive a fair share of consideration for funding needed infrastructure repair. Chairman Lee Holloway has appointed a task force on behalf of the County to address this issue and asked me to be a member. As such, I have an opportunity to advocate for our South Shore communities.

2010 Budget

My role on the Finance and Audit Committee allows me to study the upcoming budget and determine what will be necessary to keep our County sound. We expect the County Executive to present his 2010 budget proposal in September. We will consider this proposal during our autumn proceedings. As we look to next year, it will be very difficult to continue the services at the present level while keeping taxes in check. I will look for every opportunity to keep our budget reasonable and hold the line on taxes. Please contact me with your budget concerns.

While learning about Milwaukee County's precarious fiscal situation, I have come to appreciate the fiscal challenges that our County faces. We will have to make sacrifices to fulfill our mandated roles (like courts and social services), while at the same time striving to maintain the "discretionary" programs (like parks and transit) that residents depend on to meet basic needs and enhance their quality of life. I take this responsibility seriously and practice it in the way I run my own County office. My office returned 86% of my budgeted office account to the County budget. My travel expenses were \$0 in 2008 and 2009.

TRANSPORTATION

Airport Goes Local

General Mitchell International Airport is a gateway to Wisconsin. It is the first impression that many visitors have of Milwaukee. When the Transportation, Public Works and Transit Committee received a proposal for subcontractors to offer food, beverages and other amenities, most were non-local franchise operators. I advocated for and successfully won contracts with local businesses to occupy concession areas in Mitchell International Airport. As a result, we have brought in local vendors including Alterra Coffee Roasters and Nonna Bartolotta's. Already Usinger's Deli, Miller Brew House, and Legends Bar were fixtures at our Airport. We expect some more local vendors in the future. Enjoy these vendors the next time you use our airport!

College Avenue Update

College Avenue construction, from Pennsylvania to Howell Avenue, will proceed as scheduled despite the delays in construction of the US Postal Service distribution facility and related roundabouts. Milwaukee County will widen College Avenue to a 4-lane boulevard from Pennsylvania to Howell in 2010 and General Mitchell International Airport will construct the tunnel between 2009 and 2011.

Transit

As your County Supervisor, I remain determined to preserve bus service, a lifeline for many of my constituents. I am pleased that South Shore routes remained intact in 2009 and the transit system now offers a monthly bus pass for \$60. Part of this commitment includes seeking a dedicated funding source for transit. Our transit system has been devastated by continuous funding cuts and now faces a crisis. When the County first took over the bus system, the County adopted policy stating no more than 50% of funding could come from property taxes. This policy has been ignored, and County property tax dollars currently fund 65% of our bus system. At the same time, buses have not been replaced and service has been cut. We now find that we are at a crossroads in transit planning. It is clear that buses can no longer be funded with property tax dollars.

Regional Transit Authority

At the end of 2008 and into 2009, County Board Chairman Lee Holloway appointed me to lead a Task Force scrutinizing the Recommendations of the Southeastern Wisconsin Regional Transit Authority (RTA). One of our own great constituents, Tom Kujawa of Cudahy, the former director of the Milwaukee County Transit System (MCTS), agreed to serve on the Task Force. Special thanks to Tom for his insight and efforts throughout! We heard comments from experts in transit, economic development, and tourism as well as community leaders. We also reviewed the doomsday scenario if our deteriorated buses are not replaced soon due to lack of bus purchases over the last number of years.

From this testimony, the Task Force extracted several priorities: Buses have the highest priority in transit; Dedicated funding for transit should be from a sales tax and must give property tax relief; A Regional Transit Authority (RTA) is endorsed; Transit money raised in a county must stay in the county to support transit; Milwaukee County, which has the largest population, must receive proper representation on an RTA; Address other issues including debt, legacy costs and contractual obligations.

Preserving the Hoan Bridge

I adamantly oppose the possible demolition of the Dan Hoan Bridge, and I authored a letter demanding more information regarding proposals to replace it with a boulevard, ground-level bridge and open area for developers. Replacing the Hoan with ground level lift bridges is not a satisfactory alternative along I-794. Much of the rapid development in the southern portion of Milwaukee County is due to vital transportation links like the Hoan Bridge.

I coordinated a coalition of elected officials opposed to the possibility of tearing down the Hoan. Together with my office, Cudahy Mayor Ryan McCue, St. Francis Mayor Al Richards, South Milwaukee Mayor Thomas Zepecki, along with Supervisors Marina

Dimitrijevic and Christopher Larson and Milwaukee Alderman Terry Witkowski, signed a letter sent to Wisconsin Department of Transportation Secretary Frank Busalacchi asking the State to change course and plan for the necessary upkeep of the current Hoan Bridge design.

I also have communicated with our State Senator, Jeff Plale, who heads the Committee on Transportation and Tourism. I asked for information from DOT to see if financial studies estimating the cost to repair the Hoan have been conducted and if comparative ones on the cost of surface streets are underway. I am reprinting the reply here for your information.

Dear Supervisor Jursik:

Thank you for contacting me concerning the financial studies related to repairing the Hoan Bridge. I apologize for the delay in response.

Per your questions regarding the Hoan Bridge, I contacted the Department of Transportation (DOT) to acquire some answers for you. I was informed that the deck replacement and repainting of the Hoan is estimated in today's dollars to cost \$220 million. However, the DOT does not have a detailed cost of demolition of the Hoan Bridge. Further engineering is required to adequately assess the cost of the project.

Once again, thank you for contacting my office. Do not hesitate to do so in the future should further questions or concerns within state government arise. I look forward to hearing from you.
