1) Call to Order and Introductions

2) Follow-Up Presentation and Discussion on Sex Trafficking and Prostitution (PowerPoint)

Jeanne Geraci, Executive Director with the Benedict Center, and Eric Collins-Dyke, Milwaukee County Housing Division, presented on the efforts underway to collaboratively address street-level prostitution and human trafficking on Milwaukee's near southside. Milwaukee County and the Benedict Center, along with other partners, were awarded a Federal Bureau of Justice Assistance (BJA) grant to support connecting women with housing and treatment.

3) Introduction and New Vision for Milwaukee County Sheriff's Office

Chair White invited Sheriff Lucas the opportunity to introduce himself and share a bit more about his background and initial policy priorities for the Milwaukee County Sheriff's Office.

4) Act 185 - Juvenile Justice System Updates (PowerPoint)

Mary Jo Meyers (DHHS) and Mark Mertens (DYFS) provided an update on the local efforts to reduce youth from entering Lincoln Hills and transitioning them back into local supervision/care. There have been discussions on the future locations of State and Local secure youth facilities.
