Walker to Open County Pools with Free Day and Sign up for Free Summer Swim Lessons Saturday, June 14 New Partnerships are formed for Free Day & Free Swim Lessons

MILWAUKEE – County Executive Scott Walker will kickoff the 2008 summer season by opening county pools with a free swim day provided by the Chartered Financial Analysts (CFA) Society of Milwaukee on Saturday, June 14 from noon to 6pm. The first 100 children at each

pool who come early on opening day are invited to sign up for free swim lessons from 9:00am – 11:30am. The lessons will continue throughout the summer season sponsored by Northwestern Mutual.

Both the CFA Society and Northwestern Mutual have made a donation to provide the free opening day and free swim lessons in an effort to show community support. The Milwaukee County Parks will run the free swim lessons program starting with the initial sign up on opening day, and will host the free lessons every Saturday from 10:30am – 11:30 am ending on Saturday, August 16, 2008.

The season's outdoor weekend pool hours begin at noon and end at 6pm. The swim season's Monday through Friday pool hours start at noon -4:30pm then 5:30pm -7:30pm. The outdoor county pools daily admission rates for 12 + is \$1.50 and the daily rate for 11 and under is \$1. An evening swim rate for outdoor pools will be \$.75 for all swimmers after 5:30pm every day.

The cost for an outdoor annual individual season pass for age 12 years and over is \$15. The cost for an outdoor annual individual season pass for age 11 years and under is \$10. With the exception of the Cool Waters Family Aquatic Park, the passes will be valid at the following eight outdoor county pools:
